THE CATAWBA MOORINGS CONTRACT FOR INSIDE HEATED STORAGE

No charge will be made for dinghies if they are kept on or under owner's boat. If left in dry storage over the summer season, an additional charge of \$1.00 per square foot will be charged. Party of the First Part will have no liability whatsoever as a result of the Party of the Second Part.

Catawba Moorings shall not be responsible for nor have any liability whatsoever for any loss, damage, personal injury or loss of life or property within the control of the Catawba Moorings or their respective employees, agents and/or independent contractors in connection with:

- A. The Facility premises or the use of the storage space
- B. The Owner's vessel, motor, cradle or accessories, including dock box, fenders, lines, tools and associated equipment
- C. Any loss due to fire, theft, vandalism, collision, facility equipment failure, windstorm, rain, tornado, or any other casualty loss or act of God or terrorism. The Owner agrees to cover all the aforesaid risks by appropriate insurance both the Boat and related personal property without subrogation against Catawba Moorings. **The owner agrees to provide Catawba Moorings a current certificate evidencing such insurance.**

The Owner shall indemnify and hold harmless Catawba Moorings and their agents and employees from and against all claims, damages, losses and expenses including attorney fees arising out of lease of Catawba Moorings facilities or out of the Owner's operations provided it is caused in a whole or in part by a negligent act or omission on the part of the owner or anyone the owner is responsible for, regardless of whether or not it is caused in part by Catawba Moorings.

It is further understood and agreed between the Parties hereto that Party of the First Part shall provide inside storage if there is such storage available and if there is not sufficient inside storage available on the grounds of Party of the first Part, then in the discretion of Party of the First Part, said Party of the First Part may store the same on the Premises of Party of the first Part outside and not within storage buildings.

In such event, the charge for such outside storage shall be at the rates established by the Party of the First Part for outside storage as set forth in the Party of the First Part's "Contract for Outside Storage" attached hereto and made of Part hereof.

The State of Ohio Department of Industrial Relations, the Insurance Company Policy on the Storage buildings, and the need to limit theft and vandalism requires the following rules:

- 1. No electric in building
- 2. No personal vehicle in building
- 3. **No one allowed in buildings except during regular Catawba Moorings' working hours.**
- 4. Work area must be cleaned every day before leaving.
- 5. Catawba Moorings' equipment such as ladders, scaffolding, etc, will not be used.
- 6. Catawba Moorings reserves the right to move boats outside after April 1st.

Persons other than the Owner will not be permitted to work on boats in storage without the written consent of Catawba Moorings. It will be the responsibility of each person working on his/her boat not to damage or dirty other boats in storage.
